• The law concerns citizens of countries which are not European Union members

• The minimum value of the property is 250,000 euros. This sum concerns one or more properties that their total value must be at least 250,000 euros. The value is proved by the value mentioned on the purchase contract

• The property can belong to a legal entity as long as the company shares or the shareholdings belong in whole to the person that will request the residence permit

• The value of 250,000 euros concerns:

- the purchase of a real estate property

- timesharing agreement with a duration of at least 10 years, or

- lease with a duration of at least 10 years of hotel facilities or furnished homes in combined tourist facilities (according to Law 4002/2011 article 8 §2).

6 Legal check performed by the Lawyer. The lawyer of the buyer must obtain the contract deed (title) held by the vendor and search the title deed at the registry of mortgages.

This search is carried out in order to secure that:

- The vendor holds the absolute deed of the property

- The property is unencumbered

- All property taxes burdening the vendor have been paid

- The construction was completed in accordance to all planning and building permissions. Only if the title deed is secure should the buyer proceed to the final contract.
